



When **"Main Roads Only"** busing is announced, Port Huron Schools buses will travel on city streets and listed major hard-surface roads only. The list of traveled roads has been published and includes:

DO NOT TRAVEL: SUBDIVISIONS, MOBILE HOME PARKS OR GRAVEL ROADS

On **"Main Roads Only"** days students will be picked up and dropped off at the same location, morning and afternoon. It is critical that the bus drops students off after school at exactly the same location where they were picked up in the morning. In many cases, buses will be picking up students at the intersections of a main road and an untraveled

road. The location may not be a regular bus stop and may be unfamiliar to the students. To avoid the liabilities of lost or frostbitten children, we will only drop them off where we pick them up.

Students affected by "**Main Roads Only**," are those who: 1) Do not live on main roads or city streets and 2) Did not ride a bus to school on the morning of a day when "**Main Roads Only**" has been announced, must have approval from a parent or the building principal to ride a bus home. A sample of the permission slip being used at most buildings is shown below.

SIMPLY STATED:

Remember that only students who did not ride to school on a bus and who do not live on major hard surfaced roads will need permission slips. Students whose normal bus stops are on traveled roads may ride home without permission even if they did not ride a bus to school in the morning.
